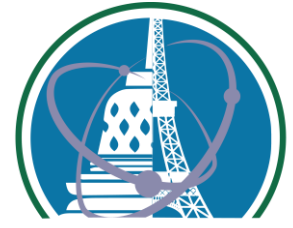

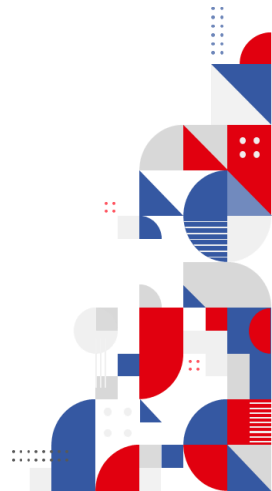

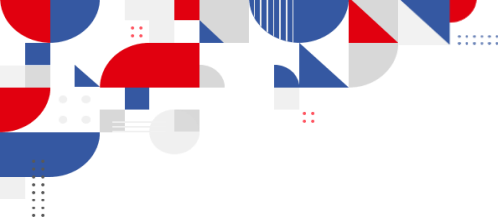

This guideline was created to assist French and Indonesian applicants to PHC Nusantara call. It is complementing the guidelines which are available on Campus France and Kemdikbudristek websites.





A. Introduction

The PHC NUSANTARA is a joint initiative between the governments of France and Indonesia, aiming to foster research and innovation partnership between academic and scientific institutions in both countries. By facilitating joint research projects, the program aims to address common challenges, share knowledge and expertise, and promote scientific cooperation. This program is managed by the French Ministry for Europe and Foreign Affairs, the French Ministry of Higher Education and Research, and the Indonesian Ministry for Education, Culture, Research and Technology (KEMDIKBUDRISTEK).

Through PHC Nusantara, promoting the new collaborations and the participation of early career researchers and doctoral students from both countries are expected. Research projects involving industry and/or international organizations are encouraged but optional. **This call is excellence based.**



Joint Funding: How does it work?

This program is for French and Indonesian researchers working in **a team** who wish to fund their partnering project.

The French government will disburse funds to French researchers and **Kemdikbudristek** will disburse to Indonesian lecturers.

Final allocation to each supported project will be decided by PHC Nusantara final joint committee. Funds must be strictly used during the calendar year, between January 1st and December 31st of each year. In no case, it may be carried forward to the following year. Any unspent funds will be deemed forfeited.

B. Aligning PHC to SAME BOPTN

All research activities contracted by Kemdikbudristek are regulated by law, including the process of research budgeting. Each selected project will receive a research grant, along with additional mobility funding. Once grants recipients are selected, Kemdikbudristek will disburse funds directly to Indonesian lecturers and the French government will disburse to French researchers.



Eligible Areas

The program supports research in any areas/disciplines except for defense or military technologies.



Eligible Candidates



Indonesian PI meeting the minimum requirements as follows:

1. Must be based in Indonesia;
2. Must be permanent lecturer affiliated with a higher education institution under the auspice of KEMDIKBUDRISTEK;
3. Must have a minimum score of 300 for STEM or 100 for Social and Humanities in SINTA;
4. Obtained the doctoral degree at least 2 years;
5. Must have strong verbal and written skills in English;
6. Active lecturer (not structural officers in the universities);
7. **Research team consist of early career researchers and/or doctoral students.**



French applicants from research laboratories affiliated with higher education institutions are eligible for this program. Companies may participate in the project as long as they are associated with an academic partner.



Expected Output



Selected teams receiving funding from the KEMDIKBUDRISTEK are expected to aim at publishing manuscripts in Q1, Q2, or Q3 international journals. Additionally:

- A progress report (laporan antara) must be submitted between September or October to KEMDIKBUDRISTEK ;
- An end of year report or final report must be sent in December.

Both reports should be submitted through <https://bima.kemdikbud.go.id/> and <https://sumberdayadikti.kemdikbud.go.id/>.



Renewal of funding for a second year is contingent upon the optimal use of the funds granted for the first year. Therefore, a report must be submitted to the French Embassy on November detailing :

- The scientific results achieved (1 page) ;
- Financial report including any mobility conducted or planned before the end of the current year.

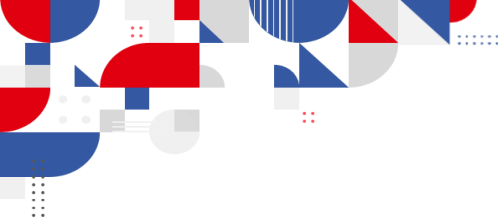
A final report shall be sent **three month after the completion of the project at the latest** to the French Embassy in Indonesia by downloading relevant files on Campus France extra-net and to affix to their online file once completed.



Budget size

For the **Indonesian side**, each project will be eligible for a research grant of up to 150 million IDR, with additional funding for mobility expenses. Details regarding what is covered and included in the mobility funding can be found in the SAME guidelines. For lecturers from polytechnics, please refer to the separate technical guidelines.

The funds allocated to the **French side** are designed to finance the researchers' mobility expenses. Please refer to **Campus France call**.



C. Application Process





How to Apply

Applications must be co-submitted in English with the same title and scope of work. The content of the Indonesian proposal should align with the research proposal submitted on the Campus France website. This ensures **consistency and coherence** between **the two proposals submitted on BIMA and Campus France websites**.

To facilitate the evaluation process, Indonesian applicants are required to include with their application, the **Dossier de candidature PHC Nusantara 2025** (please see Annex 1) that has been registered by the French partner.



Attention to Indonesian PI

- If you are interested in applying to the PHC Nusantara program, you must have a French partner and first complete the Expression of Interest (Eoi) form. Without submitting the Eoi, you will not have an access to the registration link.
- If you are a successful applicant from polytechnic, your research grant covers mobility expenses between Indonesia and France.

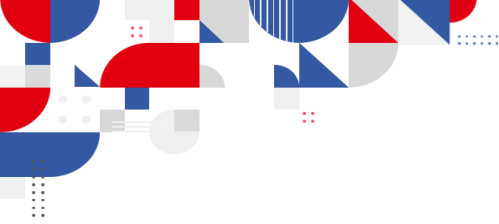
All applications must be received before the closing date. If either of the two partners fails to apply or submit an application before the deadline, the entire project submission will be disqualified.

Successful Indonesian applicants will later be requested to fulfil all requirements in conformity with the eligible funding schemes.

D. Evaluation Process

The PHC NUSANTARA call for proposals is organized **on a yearly basis**. Appointed Indonesian reviewers will assess Indonesian applications, while French reviewers will review French applications, on the similar criteria towards excellence. The proposals are then ranked in order of highest excellence first. A Joint Committee, consisting of Indonesian and French experts, will decide on the final selection of the top ranked proposals.

The reviewers are invited to note the **involvement of young researchers** studying for a Master or PhD, or pursuing post-doctoral research, which is one of the most important selection criteria. Additionally, they should consider the interest of the cooperation and the complementarity of the French and Indonesian teams. Research projects involving industry and/or international organizations are encouraged but optional.

- Call for submissions : 19 August 2024
Deadline for applications : 27 October 2024
Final selection by Joint Committee : End of February 2025
Announcement and start of project : March 2025

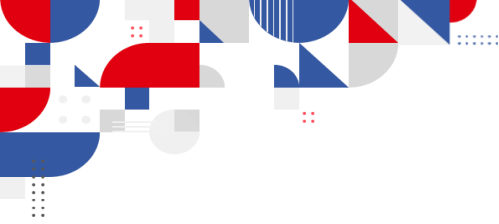

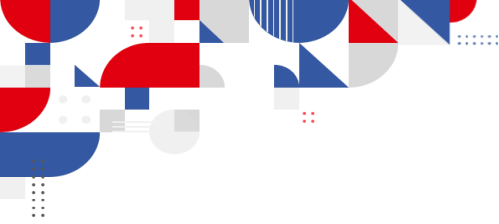
